- 4. Due to the nature of supply, ie from Generator Sets, we cannot guarantee uninterrupted supply. The electrical supplier will make every attempt to reinstate the supply as soon as possible. We will not be held liable for any loss suffered through matters beyond our control.
- 5. You are required to provide a valid electrical safety certificate (PAT test) for all electrical equipment. Where you are advised that an item of electrical equipment is faulty this shall be removed from the supply immediately and should not be re-connected without prior authorisation, from a member of the electrical supplier team.
- 6. Sub-letting of electricity supply is NOT ALLOWED and will lead to immediate disconnection of supply and confiscation of connecting leads. The same applies to unauthorised connection to supply at one of our termination points. If you connect to our supply without authority, you hereby agree to pay the maximum rate for supply available at that point, regardless of period of connection or load connected.
- 7. To comply with regulations, you are only allowed to connect and terminate supplies using Ceeform type sockets and connectors. Available for hire if required.
- 8. Any cancellations are subject to our standard terms and conditions found on our exhibitor application forms.
